## 1.) Conditions and requirements. (These conditions only apply to the Printer's Reprint Licence)

1.1) This licence remains the property of L&R Hartley, herein after referred to as the publisher.

1.2) This licence may not be transferred or sold.

1.3) This licence is for a strictly limited time period (see expiry date, above) but may be renewed as required at the publisher's discretion.

1.31) There is no limit to the number of copies that may be made, so long as they are manufactured within the time-frame of the licence.

1.32) There is no time limit for the sale of copies manufactured within the time-frame of the licence.

1.4) A separate licence is required for each item and format. (For example separate licences are required where a book is available on CD-ROM, audio, video and conventional print.)

1.5) Items may be distributed only under an authorised cover. Printer-ready artwork is available from the publisher.

1.6) Unless special arrangements are made (in advance) with the publisher, only the following wording may be added to the packaging/copyright page: "Reprinted (duplicated) and distributed under reprint rights by (licence holder's name and address)."

1.7) Unless special arrangements are made (in advance) with the publisher, the title of the reprinted publication must be identical to the original publication.

## 2. Fees and charges.

2.1) This licence is to be issued at the discretion of the publisher without charge.

2.2) A two percent (2% of the retail price) royalty is to be paid for each copy of any item duplicated or reprinted, whether or not it is immediately sold.

2.3) Payment is to be made at the time of duplication or reprinting, not at the point of sale.

2.4) For the purposes of determining royalties, the retail price may exceed but must not be less than the publisher's recommended retail price. The licence holder may sell items at a price of his/her choosing.

2.5) Royalties are non-refundable (for example, if reprints are not sold), however the publisher may occasionally choose to purchase (or find a buyer for) surplus stock.

2.6) Mastertapes/CDs and printer-ready publications

2.61) Licence holders agree to use as masters only originals purchased from the publisher. In most cases the cost of an original to a licence holder shall not exceed the normal catalogue price of the item, however...

2.62) In the case of CDs, audiovisual and multimedia items, special duplication masters are prepared for reprint licence holders. Printer-ready packaging covers, labels and slips are supplied on computer disk in Adobe® Acrobat format ready for reprinting, and licence holders must purchase this computer disk in addition to the mastertape/CD unless there is room on the CD for this extra material..

2.63) Conventional print publications (including covers) are supplied on computer disk in Adobe® Acrobat format ready for reprinting, and licence holders must purchase this computer disk in addition to a conventional print copy.

2.7) CD ROM and CD audio 'ISO' files must be duplicated 'as is' and may not be reverse-engineered.
